1. Date : 28^{th} September -3^{rd} October 2018

2. Venue : Arena Tan Sri Hamzah, Level 3, Wisma OCM, Jalan Hang Jebat,

50150 Kuala Lumpur, MALAYSIA.

3. Organizer : Malaysian Fencing Federation (MFF)

4. Competition Schedule: (Please refer Appendix 2)

5. Participation : From the host country, there will be no limited number of entries for

the individual events but a maximum of two (2) teams for each

team event.

6. Entries : Preliminary entry (by numbers) - **FORM 1**.

This form has to be received by the organizing committee not later

than 25th August 2018.

Final entry (by name) - FORM 2A, FORM 2B and FORM 3.

These forms have to be received by the organizing committee no

later than 15th September 2018.

7. Competition Rules : The fencing competition shall be conducted in accordance

with the current statues and rules of FIE. In case of disagreements in interpretation of the rules, the latest FIE rules in the English version shall prevail. The Directoire de' Technique shall deal with any unforeseen incidents not

covered by the rules.

8. Equipment : FIE equipment are not compulsory, however, rusty

weapons, torn fencing attire and short socks are not allowed. Fencer's clothing must be made of sufficiently robust material and should be in good condition. An inner plastron is compulsory. Weapon check will be done on the

piste before each bout.

9. Competition Management:

a. **Referee**

Participating club/state with a total of **more than 10 participating entries** must be accompanied by **one (1) referee / day.**

Note: Please ensure that the referees are to be properly attired. Please

bring a black jacket / blazer and long pants.

If the participating delegation fails to provide the required number of referees, a penalty fee of RM300 / day / referee will be imposed. The fee should be paid before the start of the competition.

b. Directoire de Technique (DT)

The DT will be responsible for the technical organisation of the competition.

c. Jury of appeal

The jury of appeal will consist of one representative for each participating country/state/club under the chairmanship of the Organising Chairman, or a representative appointed by him. The decision of the jury of appeal shall be final.



10. Protests : Appeals against decisions of the referee should be immediately

made by the competitors to the referee, before any decisions are made regarding the subsequent hit. If the referee could not maintain his decision, the complaint will be brought to the attention

of the D.T.

Every appeal to the jury of hit appeal must be accompanied by a deposit of **RM500.00**, which will not be refundable. This sum will be confiscated in the whole of in part if the appeal is rejected by jury of appeal. Appeals must be lodged and written in Bahasa Malaysia

and / or English.

11. Prizes : A medal will be awarded to the 1st, 2nd, and joint 3rd places in

each event.

12. Entry Fees : Individual event – RM 150 per fencer / per event

Team event - RM 480 per team / per event

Entry fees must be paid during the team manager's meeting

by cash.

Please note that the team manager's meeting will be held on the 28th September 2018 at 6.00pm at the Arena Tan Sri Hamzah (Level 3 - Wisma OCM, Jalan Hang Jebat, 50150 Kuala Lumpur,

Malaysia.)
